### PLEASE REVIEW THE FOLLOWING TEST INFORMATION

**Entries are limited to 4 TD dogs and 4 TDX dogs.** Per Chapter 1 Section 17a, **The exchange policy** will be in effect with the available tracks being filled first with untitled dogs followed by titled dogs. If the limit for entries is not reached in one test and the limit is exceeded in the other test the number of tracks will be exchanged up to the day of plotting up to the maximum allow, not to exceed the limits in Chapter 1 Section 19

Only one AKC entry form will be accepted for each dog.

**CERTIFICATION:** A certification completed in accordance with Chapter 3, Section 2 of the AKC Tracking Regulations must be submitted with the entry form for a dog that has not passed an AKC Tracking Test.

**ELIGIBILITY TO ENTER** This test is open to all dogs **Six (6)** months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, ***Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number,*** or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a ***Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.*** Wherever the word "dog" is used in these regulations it includes both sexes.

**Illegible entries** will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry and the Test Secretary will add a \$25 collection fee to the amount of each returned check. Owners are responsible for errors in entry forms, regardless of who may make such errors.

**There will be no training of dogs** on the grounds of the test the day(s) of plotting or the day of the test(s). Pursuant to: Chapter 1. General Regulations. Section 14.

**TRACKING COVER** for the TD Test will be on pasture grass.

**Bitches in season may participate:** If you know that your bitch will be in season the day of the test, notify the test secretary ahead of time. When you arrive at the test site, park your vehicle away from the other cars and notify the test secretary that your entered bitch is in season. The last track to be laid will be reserved the bitch in season. If there is more than one bitch in season, a second draw for those bitches will be held. Bitches in season will only be allowed to participate after all other dogs and bitches not in season have been tested. They must be kept away from the rest of the entered dogs. Failure to comply will result in the handler and dog being excused from the test site and any award withheld.

**TEST DRAWING:**

All interested persons are invited to attend the drawing Wednesday November 8, 2017 at 6:00PM at the Boise Public Library! 7557 W Ustick Rd, Boise, ID 83704 (SW corner of Cole and Ustick Roads)

**WORKER OPTION:** In accordance with AKC Tracking Regulations Chapter One Section 17d Test Worker Option. ICCKC will set aside 2 tracks for test workers from previous tests, as defined and identified by ICCKC. Once the tracks set aside for workers are filled, any remaining test worker entries will be added to the non-worker entries for the draw of the remaining tracks. The drawing for all tracks will be random except preference will be given to dogs which have not previously earned a TD or a TDX title.

When the advertised limit has been drawn, an ALTERNATE list will be drawn subject to the same preferences set forth above. The alternates will be advised of their positions on the alternate list and given an opportunity to be at the test site in case of absent dogs.

**Refund policy:** The entry fee shall be refunded to any confirmed entrant which withdraws, if the secretary is notified of such withdrawal prior to the running order draw and if an alternate is available to run the track. Any alternates not given the opportunity to run a track will also have entry fee refunded.

**RUNNING ORDER DRAWING:** All TD entrants must be present at the test site by 8:00AM the morning of the test for the draw for running order. TDX entrants must be present for their running order drawing at 10:30 AM. Entrants not present at the time of their respective drawing will be marked absent and an alternate will be allowed to run in their place.

**Judging will begin as soon as tracks have sufficiently aged.**

**REGULATIONS:** All exhibitors should obtain a copy of the AKC Tracking Regulations by downloading them from the American Kennel Club website at <http://www.akc.org/rules/>.

**AWARDS:** A tracking-themed mug, a new title ribbon, and our hearty congratulations will be given to each handler and dog team which passes their respective test!

**\$5 PARK ENTRY FEE: ENTRANTS MUST PAY THIS FEE AT THE ENTRY GATE AND DISPLAY THEIR RECEIPT IN THEIR WINDOW AS DIRECTED.**

**Failure to do so may result in a \$15.00 per incident fine. We encourage Idaho residents to obtain a \$10.00 season pass with their auto license renewal.**

**DOG WASTE CLEAN-UP: Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Test Committee deems the exhibitor to be in violation of this requirement.
